### Usage And Care



#### WARNING

Jib Tree, and the associated wire holders, are intended for temporary support of energized conductors to provide clearance around the workspace. The jib tree is for use on a straight line only.

All equipment must be mounted securely and must be used in a horizontal position.

Do not use this equipment if the load upon the conductors will exceed the ratings. All loads must be as balanced as possible. Install conductors to maintain as balanced as possible the load upon the jib tree.

This equipment is for temporary use under energized conditions. Temporary is defined as 72 hours under clean and dry conditions. Use for a longer period or under wet conditions will result in degradation of the jib tree and possible electrical tracking. This degradation and tracking will result in a phase to phase / phase to ground electrical arc, causing possible injury and damage to equipment.

Only wire holders and associated insulators may be mounted on the jib tree. Do not over tighten or over torque. Do not mount any other equipment. Other equipment must be mounted to a separate, appropriate device.

Clean, inspect and wipe down the jib tree with a clean cloth prior to each use. If there are any signs of degradation or moisture penetration, **DO NOT USE THE TOOL** until it has been refinished and tested.

While the jib tree is not considered primary protection, it is recommended that they are tested and evaluated for refinishing every twelve to eighteen months from date of manufacture, depending on use.

#### **General Usage Guidelines**

Please note that the instructions provided above are general guidelines for using this jib tree. These instructions are intended to provide a basic understanding of the usage and safety considerations associated with a jib tree. However, it is essential to recognize that these instructions may not cover all possible scenarios or specific requirements for your unique situation.

Before using a jib tree, we strongly recommend consulting safety guidelines and any applicable regulations or standards specific to your industry or workplace. #### **Precautions**



#### DANGER

Always maintain proper working clearances and Minimum Approach Distances (MAD) when working near energized lines or equipment. If using rubber gloves in combination with a stick that does not meet OSHA requirements, the gloves must be rated for full system voltage.



#### WARNING

Before using the jib tree, ensure the following precautions:

Make sure you are wearing appropriate personal protective equipment (PPE) such as insulated gloves, safety glasses, and protective clothing.

Inspect the jib tree for any signs of damage, such as cracks, chips, or exposed conductive material. Do not use a damaged jib tree.

Ensure that the jib tree is clean and free from any contaminants that may affect their insulation properties.

### **Electrical Ratings**

#### WARNING

Insulators, such as C1052918, must be installed to gain over surface distance for possible wet weather conditions and/or increasing phase-to-phase voltage rating to 34.5kV under clean and dry conditions. The insulators are not for personnel protection. The wire holder and mounting clamp are metal and will conduct electricity and personnel must avoid contact. Contact will result in electrical shock resulting in injury or death.

#### **Maximum Load Ratings**



#### WARNING

DO NOT EXCEED THESE RATINGS!

300 lbs. per wire holder\*

100 lbs. side load per wire holder

Max 1 wire holder per side with center Tee assembly insulator and wire holder



#### \*CAUTION

The tool has a weight capacity of up to 300 lbs. for imbalanced loads, which means it can support up to 300 lbs. of conductor on the outermost support wire holder. However, this setup is only acceptable for initial setup purposes. During operation, a balanced load must be maintained at all times.

### **Application**

The jib tree is meant to be used in a straight line with conductors not exceeding vertical or horizontal side load.

All loads must be as balanced as possible. Install conductors in a way to maintain a balanced load on the jib tree.

- 1. Confirm that the Jib Tree is securely connected to the equipment and that there is no looseness or wobbling.
- 2. Hold the Jib Tree firmly during use to maintain control and stability.
- 3. Do not exceed the recommended maximum extension length of the Jib Tree.
- 4. Avoid using excessive force or applying pressure on the Jib Tree that may cause them to bend or break.
- 5. If you need to adjust the position of the equipment or tools, do it carefully without putting excessive strain on the Jib Tree.
- 6. After use, disconnect the Jib Tree by gently pulling apart, ensuring a controlled separation.

#### Maintenance and Storage

To ensure the longevity and proper functioning of the jib tree, follow these maintenance and storage guidelines:

- Regularly inspect the jib tree for any signs of damage or wear. Replace a damaged jib tree immediately.
- Clean the jib tree with a mild detergent and water when needed. Do not use abrasive materials or solvents.
- Fiberglass equipment must be stored out of direct sunlight in a clean and dry environment. When stowed or transported, fiberglass should be placed on a padded surface to avoid damage to the finish or the fiberglass itself.
- Avoid storing heavy objects on top of the jib tree, as this may cause deformation or damage.

### **Installation**

1. The center **Tee** section is placed in the center of the fiberglass rod and secured with the loop nut, clamping the section to the fiberglass mast.



2. The outermost **wire holders** are clamped to the mast next to each end cap.



#### \*CAUTION

If the wire holders need to be moved inward, it is important that the spacing in between each wire holder has a minimum 20" of space between them.

Should the wire holders need to be adjusted, it is IMPORTANT that the load is balanced.



## Inserting Tee Clamp into Tee Mount Bracket (if equipped).

 A: Insert (longer) Clevis Pin (2) into lower hole for attaching to a jib. Secure Clevis pins with Linchpin (3). Insert Tee into square jib mount, Insert (shorter) Clevis Pin (1) into upper shaft. Secure with Linchpin (3).
B: Insert Clevis Pin (1) into lower hole for attaching to a jib. Secure Clevis pins with Linchpin (3). Insert Tee into round jib mount, Insert Clevis Pin (1) into upper shaft. Secure with Linchpin (3).

Any order for or any statement of intent to purchase any such parts or products or any direction to proceed with manufacture or shipment, shall constitute assent to said terms and conditions and a representation that the Buyer is solvent and has capacity to pay the quoted price. Any additional or different terms or conditions set forth in Buyer's order or in any other communication from the Buyer are hereby objected to by the Seller and shall not be effective or binding unless assented to in writing by an authorized representative of the Seller.

### **Prices and Taxes**

All prices are quoted in U.S. Dollars and exclude shipping charges and applicable taxes, which will be quoted separately.

#### **Warranty**

- A. We will repair or replace, at our option, any product we manufacture that has not been subject to misuse, abuse or improper application and which proves to be defective in materials or workmanship such that the value of the product to Buyer is materially impaired within one year from date of shipment. With respect to all products not manufactured by Seller or branded with the Seller's trademark, i.e., "vendor" products, Seller gives no warranty and only the warranty, if any, given by the manufacturer shall apply.
- B. Buyer shall be responsible for packing, shipping and transportation costs for returning products to us. No products shall be returned to us without our prior written consent. The acceptance of any product returned to us shall not be deemed an admission that the products are defective or in breach of any warranty, and if we determine that the products are not defective, they may be returned to Buyer at Buyer's expense.
- C. If a Product, part or accessory fails to meet the foregoing warranties, Seller shall correct the failure, at its option, (i) by repairing any defective or damaged part or parts of the Product, or accessory, or (ii) by making available at Seller's factory, any necessary repaired or replacement parts, or replacement accessory, or (iii) after issuance of prior written approval by Seller, by having Buyer repair any defective or damaged part or parts of the Product, or accessory, in accordance with Seller's product technical repair instructions and at Seller's expense, which shall not exceed the prior written approved amounts and rates. If such failure or defect cannot be corrected by Seller's reasonable efforts, the parties shall negotiate an equitable adjustment in the purchase price of the Product, part, or accessory. Any repaired or replacement part or Product or accessory furnished hereunder shall have no additional warranty period.

- D. Seller's obligations under Paragraph B shall not apply to any Product or part thereof, or to any part or accessory sold by Seller, which (i) has been modified or otherwise altered other than pursuant to Seller's written instructions or written approval, or (ii) is normally consumed in operation, or (iii) is not properly stored, installed, used, maintained or repaired, or (iv) has been subjected to any other kind of negligence, overloading, misuse or detrimental exposure or has been involved in an accident, or (v) has been disabled or adversely affected by any vendor product (other than a vendor product sold or supplied by Seller).
- E. Only an authorized Officer of Seller may modify, expand or extend this warranty, waive any of its limitations or exclusions, or make any different or additional warranties with respect to the products, and then only in a signed writing.
- F. On any resale of the products, buyer shall contractually limit its buyer's rights and remedies against both buyer and us to the same extent as buyer's rights and remedies are limited under this agreement.
- G. Products are sold with the express understanding that their life and fitness for purpose are indeterminate and largely depend on application and operating circumstances and continuing maintenance.
- H. The preceding paragraphs set forth the exclusive remedies for claims (except as to title) based upon defects in or nonconformity of the Product, or of parts and accessories sold by Seller, whether the claim is in contract, warranty, tort (including negligence), strict liability, equity, quasi-contract, or otherwise. Upon the expiration of the warranty period, all such liability shall terminate. The foregoing warranties are in lieu of all other warranties whether oral, written, expressed, implied or statutory. NO IMPLIED OR STATUTORY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE SHALL APPLY.
